CALL FOR APPLICATIONS TO GRANT 9 SCHOLARSHIPS TO UKRAINIAN STUDENTS WHO ARE WILLING TO ENROL OR REGISTER AT UNIVERSITY OF NAPLES "PARTHENOPE" FOR THE A.Y. 22/23

Art. 1

Subject, amount, and duration

The competition calls for the assignment of 9 scholarships granted to students who will enrol or register in a bachelor or master's degree program for the A.Y. 22/23 in this university.

Art.2

Requirements

To be included in the ranking , applicants for scholarship must:

- Have a Ukrainian citizenship;
- Have escaped from Ukraine due to the emergency situation;
- Have arrived in Italy after 24th February 2022, following the outbreak of the war;
- Have obtained a foreign academic qualification equivalent in level, type, content, and academic rights (access to further courses), to the Italian academic qualification required for access to the chosen study programme;
- Hold appropriate documentation certifying international protection status (refugee or subsidiary protection) or special protection status or other forms of temporary protection;
- Have completed the registration on the platform University <https://www.universitaly.it/index.php/>

At any time, and by adopting a reasoned provision, the University "Parthenope" can exclude applications from candidates who do not meet the requirements of the call. Submissions will open from 5th September 2022 until 15th October 2022.

Art.3

Application

Students will be able to apply online starting 5th September 2022 until 15th October 2022.
Candidates are strongly recommended to prepare the required documents in advance.



To complete the application, candidates must upload the following documents:

1. Copy of passport (only pages relating to personal data);
2. Copy of the degree title or certificate of enrollment certifying the eligibility to apply for a Bachelor's Degree (3 years) or a Master's Degree (single cycle programme or second cycle programme)
3. Appropriate documentation certifying international protection status (refugee or subsidiary protection) or special protection status or other forms of temporary protection
4. Curriculum studiorum
5. A cover letter in which the student describes the reasons behind the choice to apply at Parthenope, the personal educational background, information on the family status and current living conditions in Italy.
6. Declaration that the student have not been granted an additional scholarship from one of the following: Ministry of Foreign Affairs and International Cooperation (MAECI), CRUI, Foreign governments or institutions, ADISURC Regione Campania.

Art.4

Selection Criteria

1. A special Admission Committee will be nominated by the Rector. The Committee will certify the regularity of the applications and will evaluate the requirements of the candidates.
2. To each applicant, the Committee will give a score for a maximum of 100 points assigned based on the criteria outlined below:
 - Quality of the educational background of the applicant and his/her congruity to the course to which the student intends to enrol (50 points max).
 - Content of the cover letter (50 points max).
3. In the case of parity, the younger candidate will prevail over the older.
4. Once the assessment step will have been completed, the Committee will transfer the results to the office in charge for the publication on the following websites:

Art.5

Incompatibility

The students who benefit or have already benefited from another scholarship provided by Ministry of Foreign Affairs and International Cooperation (MAECI), CRUI, foreign governments or institutions, ADISURC Regione Campania, will not be eligible for the call.



Art.6

Acceptance of the scholarship

Each beneficiary will receive a communication in the same e-mail box indicated during the submission of the request.

In order to accept the scholarship, beneficiaries must reply to the e-mail to the scholarships.international@uniparthenope.it, within 10 days from the date of notification of the granting of the scholarship, under penalty of exclusion and will have to complete the registration by accessing the following links both in Italian and English.

Students' secretariat will proceed with the enrolment and registration to a course.

Students who are willing to apply in a course held in Italian will undergo a verification of their knowledge in this language from the institution according to the guidelines published in the "PROCEDURES FOR ENTRY, RESIDENCY AND ENROLMENT OF INTERNATIONAL STUDENTS AND THE RESPECTIVE RECOGNITION OF QUALIFICATIONS FOR HIGHER EDUCATION COURSES IN ITALY VALID FOR THE ACADEMIC YEAR 2022-2023". The scholarship will be paid only if the successful candidate is admitted to the Degree Course and has fully completed the enrollment within the terms allowed for the Academic Year 2022/23.

Art.8

Payment and Scholarships Maintenance Requirements

Students who resulted as "eligible" will have to communicate their bank account details to Students' Secretariat, in order to enable the refund of the university tuition fees, as well as the payment of the balance of the scholarship for the eligible students who resulted beneficiary by filling in the Model A to the office in charge.

The scholarships consists of:

- Exemption from payment of university fees for the A.Y. 22/23 with a possible extension to the A.Y. 23/24;
- Grant of 500€/month paid on a prepaid card or bank account registered under the name of the beneficiary; The amount will be paid each 4 months (starting from the date of publication of the ranking list) for a total of 3 instalments;
- Costs to cover the stay at the Residence Hall of Adisurc- Parthenope for 12 months for a maximum of 200 €/month;

To apply to this open call application, candidates must:



- Finalize the registration at University Parthenope within the deadline set by the institution for the A.Y. 22/23;
- Have proof that they entered Italy after February 24th 2022 as per Council Implementing Decision (EU) 2022/382 (ex. Stamp on the passport);
- Open a bank account in Italy or must be holder of a credit card/pre-paid card linked to an IBAN registered or co-registered on the behalf of the beneficiary;
