Art. 2 A communication will be sent to every winner using the email address chosen during the application process. To accept the scholarship the winner must send an email to scholarships.international@uniparthenope.it, within 10 days after receiving the notice, at the risk of being excluded. The payment will happen only if the winner will be admitted to the Course and will complete the enrollment within the established terms set by the university.

International students who need a visa must obtain it and – once in Italy - apply for a permit of stay for study purposes. The scholarship will be withdrawn if the students does not obtain the visa or does not apply for the permit of stay.

Art. 3 After checking the declarations written on the application form, in every stage of the process it might be possible to exclude the students who made false declarations.

Art.4 The original version of this ranking has been written in Italian language and this translation is only meant for informative purposes; for the resolution on any dispute and for each legal effect the only one to be taken into consideration is the Italian one.
